**Sub: JFMTI All India Executive Summit on Proposed NCHRH Bill 2011
at PGIMER, Chandigarh, on 29th January, 2012, Sunday (10:30 AM to 2:30 PM)**

Dear Colleagues,

As you may be aware that long pending NCHRH Bill 2011 has been introduced in parliament on 22nd December, 2011 and Department related Parliamentary Standing Committee on Health & Family welfare has also invited suggestions/views from organisations/institutions and individuals for wider consultation on this national health issue. Furthermore, you may also be aware about the recent News in all leading national newspapers about preliminary reaction of JFMTI on proposed bill.

However, such suggestions had already been invited by concerned ministry on preliminary draft of this bill during October, 2009. JFMTI had organised a National Debate on this issue in Delhi and submitted a joint memorandum incorporating the suggestions of all allied health associations to all concerned government authorities and now revised draft of Bill has been introduced in parliament and seeking similar suggestions again. Though detail discussion had already there during National Debate in Delhi but there are certain new points in Bill which requires your attention again.

Therefore, considering it an important agenda point, we have proposed to organize a National Summit of JFMTI Executives, Advisors and experts on this important issue on 29th January, 2012 at PGIMER, Chandigarh, as joint memorandum has to be submitted before 8th Feb, 2012 to the Parliamentary Standing Committee.

Further, it is requested to all leaders of JFMTI affiliated organisations to send your suggestions specifically referring to clauses of the proposed Bill to JFMTI through email before 20th Jan, 2012. You can also send your suggestions through suggestion box on JFMTI website. Copy of NCHRH bill is also available on JFMTI website: www.jfmti.com under JFMTI Updates Column. It will enable us to prepare a semi final draft of our submission which is to be discussed during our National summit on 29th January 2012. Besides NCHRH issue, meeting will also be an opportunity to discuss several other important agenda points of JFMTI. Participation is limited to members of JFMTI affiliated associations but prior information is necessary if any other health organisation/individuals are willing to participate in this meeting. All concerned are requested to confirm your participation at the earliest through email/or phone so that organizers may not have any problems in facilitating the event.
